## Application for Tenancy (Houses/Apartments)

This form must be completed and signed before any application for tenancy can be formally considered. Applicants are reminded that in addition to the reference information requested herein, they must also provide proof of identification.

We charge a 'Reference Fee' of £78 (inc. VAT) per person. This fee is to cover the costs of processing your tenancy request and, therefore, is non-refundable; however, it will be reimbursed should the landlord or agent withdraw for any reason. <u>Each individual prospective tenant must complete an 'Application For Tenancy' and pay the 'Reference Fee'</u> as appropriate. NB: A guarantor will be charged the 'Reference Fee'.

If your application is successful you will be required to pay advance rent and a security deposit before the commencement of a tenancy and a 'Check-in Fee' of £150 (inc. VAT). This deposit will be held by us as stakeholders. The deposit will not be returned until your tenancy is ended, and only then, provided the obligations of your tenancy have been met in full, the final household bills are paid (we may require proof) and the property is returned in a satisfactory condition. NB: Before the deposit is refunded we will also have to consult with the landlord. A 'Check Out' Fee of £78 (inc. VAT) will be payable.
